Subject: Revised Plan for Study 3.3.19

Dear Mr. Donohue:

On August 14, 2013, FirstLight Hydro Generating Company (FirstLight) submitted a revised study plan that included a study evaluating the effectiveness of using ultrasound to guide the upstream passage of American shad at the Turners Falls Project (study 3.3.19). On February 21, 2014, the Commission issued a study plan determination that approved the study with a modification. The modification required FirstLight to revise its plan for the study, if appropriate, after completion and review of study 3.3.2, which is a study of the effects of project operation on the upstream and downstream passage of adult American shad. The modification also required FirstLight to distribute its revised plan for study 3.3.19 to stakeholders for comment and file the revised plan for Commission approval.

Study 3.3.2 is only partially complete; however, FirstLight believes it has adequate information to proceed with study 3.3.19 during the 2016 field season. Therefore, on January 13, 2016, FirstLight provided stakeholders with a draft revised plan for study 3.3.19 and requested comments by January 26, 2016. FirstLight received comments from the U.S. Fish and Wildlife Service, National Marine Fisheries Service, Massachusetts Division of Fisheries and Wildlife, Don Pugh, and Karl Meyer. On February 19, 2016, FirstLight filed and requested Commission approval of its revised plan for study 3.3.19.1

Commission staff has reviewed the revised plan, stakeholder comments, and FirstLight's responses to comments and conclude that the proposed study should provide
